**RESULTS OF VOTING AT THE GENERAL MEETING**

The 33<sup>rd</sup> Annual General Meeting of the Company was held at 10.00 AM on 5<sup>th</sup> August 2019 at Rajah Annamalai Mandram, No.5, Esplanade Road (Near High Court), Chennai – 600 108.

Pursuant to the provisions of Companies Act, 2013 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided e-voting facility through CDSL platform to its members for voting on resolutions proposed in the AGM Notice. E-voting commenced on 2<sup>nd</sup> August 2019 at 9:00 AM and ended on 4<sup>th</sup> August 2019 at 5:00 PM.

As per the requirements of Rule 20 of the Companies (Management & Administration) Rules, 2014, as amended, Members who had not availed the e-voting facility, were provided an opportunity to cast their vote at the venue by Poll.

M/s B Chandra & Associates, Practising Company Secretaries were appointed as the Scrutinizers for both e-voting and polling at the venue. The voting by the members through e-voting and by poll at the venue of AGM have been consolidated and the Scrutinizers have submitted their report vide copy enclosed.

b.	The Public Advertisement with respect to dispatch of notices and conducting of voting through electronic means was published in newspapers in English in "Financial Express" and in Tamil in "Makkal Kural" on 13 <sup>th</sup> July 2019
c.	The e-voting period commenced on August 02, 2019 at 9:00 A.M. and ended on August 04, 2019 at 5:00 P.M.
d.	Accordingly, the electronic votes cast were taken into account and at the end of this voting period, i.e. on August 04, 2019 at 05:00 P.M, and the CDSL portal was blocked for voting.
e.	The votes cast were unblocked in the presence of two witnesses on the August 05, 2019.
f.	The Corporate members who had participated in the e-voting had provided the copies of the relevant resolutions/documents for authorization to exercise their votes through E-Voting.



At the Annual General Meeting held at the scheduled time, date and venue, the Chairman announced a poll taking into account the provisions of law as well as the clarifications dated 19-03-2015 issued by the Ministry of Corporate Affairs.

The polling papers in **Form MGT-12** as per Companies (Management & Administration) Rules, 2014 were distributed to the shareholders present. The shareholders cast their votes in four ballot boxes kept at convenient locations in the Venue.

1. At the time fixed for closing of the poll by the Chairman, all the ballot boxes kept for polling were locked in my presence with due identification marks placed by me.
2. The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company and the authorizations/proxies lodged with the company.
3. None of the poll papers were found to be incomplete or were otherwise found defective and hence there were no invalid votes.
